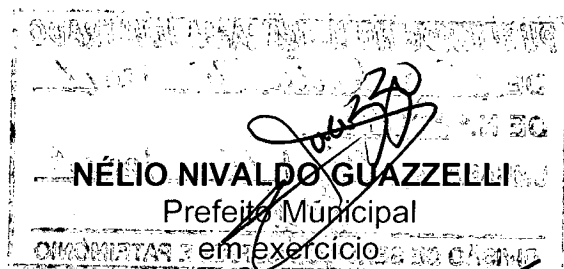
O PREFEITO MUNICIPAL DE UMUARAMA, ESTADO DO PARANÁ, no uso de suas atribuições legais,

RESOLVE:

Art. 1º. Alterar a contar de 04 de julho de 2008, o percentual de 5% (cinco por cento) de Incentivo de Progressão por Qualificação do Trabalho Docente à servidora **CELCINDA FERREIRA DE AZEVEDO**, portadora da Cédula de Identidade RG nº 5.204.523-1-SSP-PR, nomeada em 09 de fevereiro de 2001 pelo regime Estatutário, para ocupar o cargo de carreira de Professora, lotada na Secretaria de Desenvolvimento Social – Diretoria de Educação, passando o percentual de Incentivo de Progressão de 10% (dez por cento) para 15% (quinze por cento), com base no artigo 16 e parágrafo único da Lei Complementar nº 064/99, nos termos do processo nº 7197/2008.

Art. 2º. Esta Portaria entra em vigor a partir da data de sua publicação, ficando revogada a Portaria nº 908 de 17 de outubro de 2006.
